RESOLUTION NO.5 SERIES 2020

WHEREAS, Section 13.2.320 of the Code of the City of Rocky Ford, Colorado, concerning water rates and charges, as amended by Ordinance No. 914, provides that the City Council may by resolution reduce or increase the rate of charge, classify or reclassify any recipient of such water for rate purposes, and may further establish by such resolution the charge to be assessed against any future industrial or business water recipient;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF ROCKY FORD, COLORADO AS FOLLOWS:

Rates for water taken from or used through the water pipes of the City of Rocky Ford, Colorado, shall be as follows effective May 21, 2020 with the first billing to occur in June 2020.

THE MONTHLY CHARGE FOR USERS INSIDE THE CITY LIMITS

- A. Residential Users and Commercial Users Inside the City Limits
 - 1. 3/4" Meter service charge & First 1,000 gallons* \$35.63
 - 2. After the First 1,000 gallons \$2.66 / 1,000 gallons or portion thereof
- B. *Minimum Residential and Commercial Service Charge for Inside the City Limits for taps over 3/4" including first 1,000 gallons.

 - 2. After the First 1000 gallons \$3.97 / 1,000 gallons or portion thereof
- D. *Minimum Residential and Commercial Service Charge for Outside the City Limits for taps over ¾" including first 1,000 gallons.
